The VFS will be subject to change as per NY MGO Fuel prices on Bunkerworld.com and the corresponding index above. The New York MGO price will be recorded daily from Bunkerworld.com and on the 15th of each month the previous 30 day average will be used in the index above to determine any changes to the VFS. If an adjustment is necessary the change will occur on the 1st of the following month. The starting Bunker amounts are highlighted in the Index.
