Fuel Surcharge: Except as otherwise provided, a mandatory Fuel Surcharge will be assessed on all shipments in addition to all other rates and charges published herein as follows:

- For all NSAs and NRAs filed and in effect prior to April 1, 2019, the Fuel Surcharge (FSC) will apply as outlined below.
- Effective April 1, 2019 all FCL rates will be subject to the Vessel Fuel Index (VFI) found in rule 12.2, as well as the Low Sulfur Surcharge (LSS) found in rule 12. This change will apply to all NSAs, NRAs, and tariff rates filed after March 31, 2019.

Exception –

- All rates for service between the Continental US and Puerto Rico will continue to apply as outlined below.
- All rates for LCL service will continue to apply as outlined below.

As per Tariff 015721-003 all shipments to Puerto Rico are subject to the Vessel Fuel Surcharge (VFS). The VFS will be subject to change as per the NY MGO Fuel prices on Bunkerworld.com and the corresponding index above. The New York MGO price will be recorded daily from Bunkerworld.com and on the 15th of each month the previous 30 day average will be used in the index above to determine any changes to the VFS. If an adjustment is necessary the change will occur on the 1st of the following month. The starting Bunker amounts are highlighted in the index.
