Advance Charges Fee

Between Continental U.S. and Central America and Countries, Ports & Points listed in Rule 1

A. Applicable on Southbound or Northbound LCL or FCL Shipments Between Continental U.S. and Guatemala:

Unless as otherwise specified, an Advance Charge Fee will apply to all shipments when Carrier advances charges in Guatemala on behalf of the customer to facilitate the movement of cargo. This can apply but not limited to Document Handling Charges, Customs Fee's, Seals, Cargo Inspections, Wharfage, Port Storage Charges, Port Handling Charges and Freight Charges. Carrier will not advance fees for VOCC Carrier Detention/Demurrage Charges, Fines & Penalties imposed by Carrier or Governmental Entities. Advance Charge Fee shall be applied as per the below table of charges. Advance Charge Fee is based on a percentage of the total amount advanced by Carrier. This rule does not apply to Advances Charges of USD \$50.00 or less. Carrier will not advance Fee's exceeding USD \$1000.00. Advances exceeding \$1000.00 will require prior Carrier approval.

B. Applicable between the Continental U.S., Puerto Rico, Far East, Caribbean, Central America & the Dominican Republic:

Except as otherwise provided, when carrier advances charges or pays COD Charges in the U.S. on behalf of the customer in order to facilitate the movement of freight to its final destination, carrier will assess a %3 Advance Charge Fee - COD on all funds paid by carrier. Maximum amount of charges advanced by carrier is not to exceed \$2500.00

Between Cross Trade (Informational)

C. Applicable for LCL or FCL Shipments Between Guatemala: Unless as otherwise specified, an Advance Charge will apply to all shipments when Carrier advances charges in Costa Rica, El Salvador, Guatemala, Honduras or Panama on behalf of the customer in order to facilitate the movement of cargo. This can apply to (not limited to) Document Handling Charges, Customs Fee's, Seals, Cargo Inspections, Wharfage, Port Storage Charges, Port Handling Charges and Freight Charges. Payment terms on charges advanced will be a maximum of 8 days. Advance Charge Fee shall be applied as per the below table of charges. Advance Charge Fee is based on a percentage of the total amount advanced by Carrier.
