Warehousing/Storage Charges

Except as otherwise provided in an individual rate items, the following schedule of warehousing charge shall apply in addition to all other rates and rules applicable in this tariff. Below schedule is for use in conjunction with ocean shipping services and subject to the following conditions.

Carrier Terminal Charges within the Continental United States

A. Dry Storage/Pallet Transfer/Certified Pallet & Shrink Wrapping: Unless otherwise specified, below table of charges are applicable for US Exports at US Locations only.

1. For purposes of this Rule, the term "Shipper" shall mean the Shipper, the Consignee or any person acting for or on behalf of the Shipper of Consignee.
2. Storage charges are applicable when cargo is held in the Carrier's possession beyond the applicable origin or destination free time period and is a charge relating to use of the storage location.
3. When a shipment is held beyond the scheduled sailing date due to a request by the Shipper, the shipment will begin to incur per diem storage charges, commencing as of the date the scheduled vessel sailed.
4. In the event Shipper fails to provide the proper export documentation by the scheduled sailing date, the Carrier will assess storage charges, following the expiration of the appropriate free time as indicated, until documentation is received by the Shipper.
5. Storage charges, if applicable, will be assessed on each calendar day, or fraction thereof excluding date of sailing.
6. Perishable goods or goods which are susceptible to damage through temperature changes or other causes incident to storage, will be accepted for storage solely at Shipper's risk and Shipper shall indemnify and hold Carrier harmless from any and all liability and expense for such damages as might result from storage conditions unless caused by the negligence of Carrier.

For the purpose of this rule, Segregation is defined as when Carrier is requested to break pallets, boxes or any other means of outer packaging materials to remove inner pieces, packages or boxes from the original receipt of goods by hand for unloading/loading purposes. This Sub-Part Rule C is not applicable if Mechanical Means are needed to segregate Freight due to weight, length, width or height except when needed to move/transport final pallet, box or other outer packaged piece created.
