**Exceptions:**

- 40' reefers imported to the United States and destined to South Florida Dray zones via a South Florida port are *exempt* from the overweight permit.
- South Florida Dray zones (via a South Florida port), the overweight charge is \$50 per container.
- Jacksonville Local Dray (via a Jacksonville port), the overweight charge is \$50 per container.
