Crowley will be utilizing the CASS Index to monitor costs and adjust all inland rates via any US port in Tariffs and Contracts. The index can be found on the [Cass Information Systems, Inc. website](#).

Crowley will review the average index values for Truckload Linehaul. If the index increases or decreases by more than 2% from the baseline amounts, we will announce the change and adjust the inland component of tariff and contract rates by an equal amount 30 days later. If there is less than a 2% change then there will be no adjustment and the Current Baseline will remain unchanged. If there is an adjustment, then the Current Baseline will be updated to reflect the new baseline.

Crowley will calculate the average of each month. If the average price is higher or lower than the current index tier average price, Crowley will adjust the inland charge based on corresponding tier approximately thirty (30) days later.
