A. U.S. Port Security Surcharge Between the Continental U.S. and Puerto Rico Ports; the US Port Security Surcharge shall be assessed on a per Cubic Foot (Measure) or per 100 Lbs (Weight) basis for LTL shipments and a flat fee per container.
